The Board of Directors of the Palestine Economic Development Corporation met on Thursday, April 21st, 2016 at 11:30 am at the Palestine Municipal Airport located at 1278 County Road 421.

A. Call to Order

B. Citizen Input

Manager of Palestine Jet Center LLC, Gaylon Addkison, welcomed us to airport business office and accepted a \$10,000 PEDC grant that partially funded building of their newest hanger. The business has grown over 30% since opening three years ago. Sanderson Farms is their primary customer, and two air ambulance services run in and out of the airport. Their next new business target is an aircraft paint shop. Additional new business is coming from nearby airports. The new hanger can store 6 planes and one helicopter and the company plans to add six more jobs for their long term future.

- PEDC now owns our office space.
- Currently talking with realtor in Tyler about potential tenant for Suite B of our office.
- Project Call Me Baby expressed interest for 60 to 90 day rent space, Suite B, 100 Willow Creek Parkway.
- PEDC will host an Economic Development Incentives Meeting on Thursday, May 5, 2016 at 5pm, at the Ben E. Keith Community Room. Discussions will cover tax abatements & attracting and retaining businesses. This is a by invitation meeting with invited leaders of the community.
- PEDC will host an Accountability Roundtable for 20 to 30 community business leaders and decision makers on Thursday, May 26th. The facilitator of this event will be Sam Silverstein Inc., a complimentary consulting service.
- Current PEDC Pipeline includes a significant number of new jobs, public announcement forthcoming.
- The week of March 21, 2016, PEDC hosted a site visit for company representing significant employment to community.
- Discussion held concerning new phone system that includes voice mail and CRM system specific to economic development.
- Also mentioned was new sealed bid for Mall pad site, with more details coming later.
- Updates were provided on five existing projects.
- Main Street -- the downtown quiet zone proposal continues to progress with public hearing held 4-25-16 at City Hall.
- Main Street the bat, pigeon, and asbestos grant was discussed.
- Main Street five RFP's are under review for downtown assessment survey.
- Tourism -- we advertise on Facebook, Instagram primarily. Ads located in Texas Monthly, Real Simple, Trip advisor, and Texas Highways magazine have been very successful.
- Tourism May 3, 2016 at 6pm, Ben E. Keith Community Room, 2019 W. Oak, Palestine, TX will be the meeting place for a seminar on how to apply and receive funds from the Local Hotel Occupancy Tax Program. The Palestine visitor Center is hosting this seminar & Brian Sullivan, Associate General Counsel for the Texas Hotel & Lodging Association is guest speaker. This meeting is an open invitation to the community.
- Tourism the 1836 Chuck wagon Races took place at Diamond B Ranch on April 23 & 24.
- Tourism The Visit Palestine 5 Year Strategic Plan outline was presented to City Council on April 25th, 2016 as part of the City Manager's report.
- Tourism 2016 Visitor Guides will be sent to 417 sites along I-20 East, Tyler, North Houston, Shreveport and I-45 Dallas to Conroe areas.

 assist, and Greg Laudadio will spearhead this project forward.
- 2. Discussion and possible action regarding payout to YMCA for 2014 and 2015 Community Development Grant. The Y was awarded \$17,500 in 2014 and \$10,850 in 2015. Phase 1 project completion holds a September 10, 2016 completion date, therefore no action taken.
- 3. Discussion and possible action regarding Downtown Quite Zone. No action taken.
